This matter having been opened to the Court by the non-party Morris County Prosecutor’s Office, Chief Assistant Prosecutor Christopher F. Schellhorn appearing, for an Order directing production of certain items from the Morris County Prosecutor’s Office investigative file pursuant to Defendant Sweet Grass Farm’s *Subpoena Duces Tecum*, and the Court having considered a letter submitted herein, and for good cause having been shown, including all reasons noted on the record on Friday, November 4, 2022;

**IT IS ON THIS 14th DAY OF November, 2022, ORDERED** that the non-party Morris County Prosecutor’s Office shall produce the following specified items contained on three cell phones recovered during the criminal investigation and identified as **Morris County Sheriff’s Office Item Number 1, Morris County Sheriff’s Office Item Number 14** (redacted), and **Morris County Sheriff’s Office Item Number 26:**

- All call logs recovered from the forensic data extraction of each device identified in this Order;
- All text logs, including the content of each text message, recovered from the forensic data extraction of each device identified in this Order; and
- Any social media recovered from the forensic data extraction of each device identified in this Order that has not been previously produced pursuant to Defendant Sweet Grass Farm’s *subpoena duces tecum*.

IT IS FURTHER ORDERED that the production of said forensic extractions shall occur no later than 10 days from the date of This Order.

IT IS FURTHER ORDERED that the production of said forensic extractions shall be consistent with and protected by the June 23, 2021 Confidentiality Stipulation and Protective Order previously entered by the Hon. William J. McGovern, III, J.S.C.

ORDERED that failure to comply with this Order shall subject the non-compliant party to sanctions pursuant to R.4:23; and it is further

ORDERED that service of this Order shall be deemed effectuated upon all parties upon its upload to eCourts. Pursuant to R.1:5-1(a), movant shall serve a copy of this Order on all parties not served electronically within seven (7) days of this Order.
