BAMR Bermuda is directly owned by BAM Re Holdings Ltd., a non-publicly-traded company that is directly owned by Brookfield Reinsurance Ltd., a publicly held company.

Thus, Farm Family is indirectly owned by Brookfield Reinsurance Ltd., a publicly held company. No publicly held entity directly owns 10% or more of Farm Family’s stock.
